NOTICE TO THE MARKET

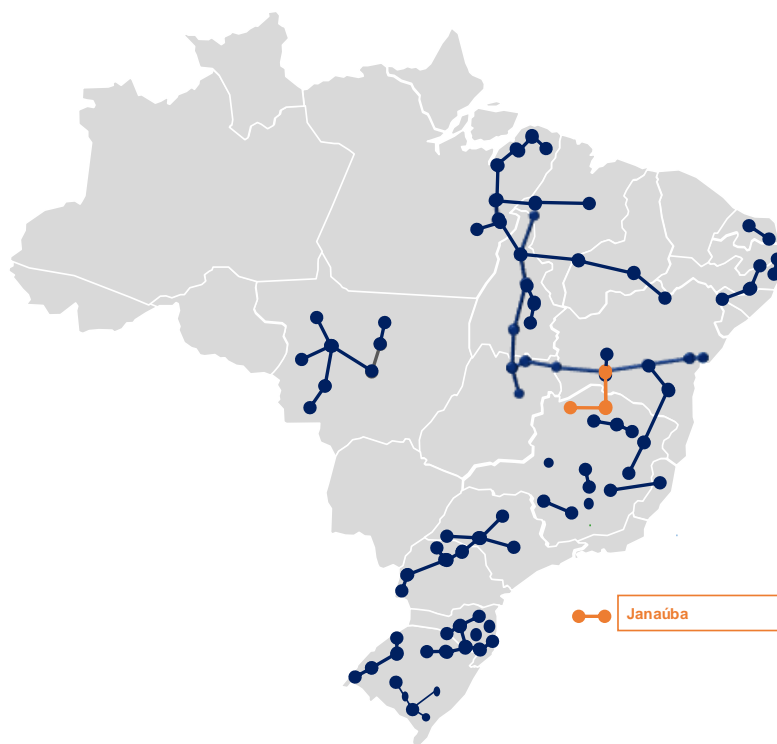
Transmissora Aliança de Energia Elétrica S.A. (“Taesa” or “Company”) announces that, on September 1, 2021, it delivered the project Janaúba Transmissora de Energia Elétrica S.A. (“Janaúba”), 100% controlled by the Company, in reference to lot 17 of the transmission auction No. 013/2015 (part 2), conducted in October 2016. As such, the Janaúba concession became commercially operational, generating an additional R\$ 213.6 million of Annual Permitted Revenues (RAP) for the Company.

The project was delivered 5.5 months ahead of ANEEL’s required deadline on February 9, 2022 and achieved cost savings of approximately 18% in comparison to ANEEL’s stipulated capex, resulting in a total investment of R\$ 950 million. This demonstrates Taesa’s execution capabilities as well as a commitment to its strategic pillars of sustainable growth, financial discipline, operational efficiency, and value creation.

The development employed an average of 881 people per month. Additionally, more than 30,000m³ of concrete, more than 12,000 tons of structural framework and more than 12,000 tons of conductor cables were utilized, as well as developing 26 crossways throughout the project’s entire course.

It is important to note that Janaúba is the Company’s largest *greenfield* project delivered to date, with an extension of 542 km of lines located between the states of Minas Gerais and Bahia, and encompassing the following transmission lines: LT 500 kV Bom Jesus da Lapa II - Janaúba 3 (304 km of Single Circuit) and LT 500 kV Janaúba 3 - Pirapora 2 (238 km of Single Circuit) and three substations of 500 kV (Bom Jesus da Lapa II, Janaúba 3 and Pirapora 2).

The project increases the transmission capacity between the Northeast-Southeast interconnection, providing the necessary scaling of the National Interconnected System (“SIN”) to carry, without electrical restrictions, the power produced in new power plants in the Northeast region of the country, and allowing for future expansion of the system. As such, and in line with the Company’s commitment to the Sustainable Development Goals (SDGs), Janaúba contributes to the delivery of renewable energy to the SIN and consequently, to a cleaner global energy grid, with a positive and permanent impact to the country’s growth and socio-economic development.



Taesá reinforces its focus on execution and timely delivery of projects currently under construction, totaling R\$ 2.2 billion in ANEEL investment and approximately R\$ 400 million in RAP (considering Taesá's stake for the 2021-2022 cycle). The Company continues to work towards achieving capex efficiencies and meeting deadlines with the goal of leveraging each project's returns.
